



## Leukaemia Research Centre opens



The Paul O'Gorman Leukaemia Research Centre was opened by Dr Richard Rockefeller on Thursday 22 May 2008.

Opening the centre, Dr Rockefeller, a leukaemia survivor himself, paid tribute to the staff and said their work is vital: 'Leukaemia is a particularly harsh illness and anything that can be done to combat it is incredibly important.'

'The Paul O'Gorman Leukaemia Research Centre will play a huge part in the battle against this condition and I am proud to have been asked to open this world-class facility.'

'The work being carried out here by Professor Tessa Holyoake and her team is staggering in its scope and

complexity, but the results will mean we understand more and more about leukaemia.'

The £3 million centre is kitted out with the latest technology and will allow specialists to translate laboratory findings into new treatments for patients.

It was built after a fundraising drive by the University of Glasgow, which saw more than £2.6 million raised in six years, through the commitment and generosity of more than 1,800 donors and supporters.

## Dr McKay's legacy

The University received one of the largest bequests in its history from Dr James McKay, who left the residue of his estate to promote teaching and research in the traditional academic disciplines. A total of £930,000 was received in 2008.

The sizeable bequest has allowed funds to be directed to a variety of projects, including the Beatson Pebble Appeal, the Small Animal Hospital and an endowed postgraduate scholarship in cardiovascular medicine.

Dr McKay was a 1957 medical graduate who, during his lifetime, supported the fundraising project to build the Wolfson Medical School Building – a world-class teaching and learning facility for students training to work in his chosen field.

Cathy Bell, Director of the Development & Alumni Office, comments: 'The University has been the recipient of many bequests from alumni and friends over the years, however Dr McKay's gift numbers amongst the largest. We are extremely grateful to him for his generosity and foresight.'

'This bequest will make a lasting difference to the projects it has supported.'

### Healthy working lives appeal

The Healthy Working Lives Research Group (HWLRG) based at the University has grown and successfully contributed to teaching and research on the health of the working-age population for 17 years. The HWLRG's purpose is to improve the health and workability of the population by undertaking teaching and research in the field of occupational health and safety, sickness absence management, rehabilitation case management, the prevention of work-related ill health, and the improvement of the functional capacity of individuals and fitness for work. In recent years the group has generated over £5 million income in external research grants, leading to many research publications and reports. The group has also been involved in design and delivery of courses to improve the competence of occupational health professionals and developed the healthy working lives concept.

An expansion of the HWLRG is now underway which will see the appointment of a senior clinical academic and in order to fund this post an appeal has been launched. Greater Glasgow & Clyde Health Board and the Scottish Government are both supporting the appeal along with Rolls Royce and a number of individual donors. Dr Ewan Macdonald (Head of HWLRG) said: 'Scotland has an ageing population with far too many people of working age on long-term incapacity benefit, which is associated with child poverty, early death and great health inequality. It is vital, even in a time of economic challenge, to improve the workability of our population, so that when recovery comes, we have the healthy workforce to further develop the economic success of Scotland. The work of this group has been internationally recognised and needs to be developed further.' # The Beatson Pebble Appeal launch

## Old Firm stars kick off appeal

The captains of Celtic and Rangers Football Clubs launched the campaign to build a new cancer research centre for Scotland.

Stephen McManus and Barry Ferguson gave their support to the £10 million Beatson Pebble Appeal and have urged the public to back the campaign and help to beat cancer.

Both clubs are supporting the drive to raise funds to build the Beatson Translational Research Centre, the final element in the creation of the Glasgow Centre for Cancer Research. The centre, which will be built at Garscube Estate in Bearsden, will convert basic cancer research into real improvements in treatments for patients. The scientists housed there will focus on all types of cancers that affect all ages. Cancers such as breast, prostate, ovarian, lung, throat, mouth, stomach and intestinal, some of which are the most common in Scotland, will all be studied.

The captains both attended the official launch to show their support and met up with cancer survivor Lynn Murray. Lynn had treatment for both bone cancer and breast cancer and is heavily involved in fundraising for the new centre, as Cathy Bell outlines in the Director's message on page 2.

Rangers and Scotland captain Barry Ferguson said: 'This is an important campaign for Glasgow and for Scotland. Cancer affects so many people from all walks of life that anything we can do to tackle it is vitally important. Rangers are right behind this campaign and the fight to treat cancer.'

Celtic captain Stephen McManus said: 'We all know someone who has been diagnosed with cancer and we have all seen the pain it causes. This new centre will play an important part in helping those who are battling the disease and everyone at Celtic is supporting the Beatson Pebble Appeal. If we work together, we can all help in the fight against cancer.'

## University of Glasgow scholarships

### Attracting and supporting talented students

Margaret L Ritchie sadly passed away in May 2007 leaving the Department of Chemistry a share of the residue of her estate which totalled £36,000. The department has directed funds to endow a Talent Scholarship, to attract and support



bright undergraduate students who might not otherwise have the means to attend university.

Pauline Perkins, Mrs Ritchie's next of kin and long-standing friend, commented: 'I was so thrilled that the money will be put to such good use, as I know Margaret herself would not have been able to go to university if it hadn't been for a bursary gifted to her. I know she would have been pleased that the funds will help others in a similar situation.'

Mrs Ritchie graduated with a BSc in Chemistry in 1949. She went on to work as a chemist with Glaxo Pharmaceutical Company before returning to Scotland in 1989 where she settled. Throughout her lifetime she maintained a connection with the University.

Professor David Jackson, Head of the Department of Chemistry, said: 'We are tremendously grateful to Mrs Ritchie for this gift to the department. The endowment of her bequest will ensure ongoing financial support for talented students choosing to study here. It is extremely encouraging to us all that Mrs Ritchie thought so highly of her time at Glasgow that she decided to give something back in this way.'

The first Margaret L Ritchie Talent Scholarship will be awarded in the academic year 2009-10.

### Vet graduate helping students of today

A 1943 graduate of the old Glasgow Veterinary College returned to Glasgow recently to visit the Faculty of Veterinary Medicine and to offer his support to the current generations of students.

Dr Lewis Forbes, who now lives in California, has generously offered major support to veterinary students, by setting up a scholarship to help those who are suffering financial hardship during their studies. 'I was



astounded to hear how much it costs students to complete their degree and the levels of debt they can leave with these days. I put myself in their shoes and realised how much harder it is for students today. I was lucky in that I received a Carnegie Award when I was a student. As I came from a poor family, I would not have been able to attend the Vet College without this support.'

A native of Kirkintilloch, Dr Forbes joined the Army Veterinary Corps on graduation and served for four years, seeing service in Burma, Vietnam, Cambodia and India. At the end of the war, he volunteered for the Colonial Service and was posted to Uganda. He returned to Scotland to study for his Diploma of Tropical Veterinary Medicine at the Royal (Dick) Veterinary College in Edinburgh, which he was awarded in 1956, and in 1959 he received a Fellowship in Animal Industry from the Food and Agricultural Organization of the United Nations.

He joined the US Department of Agriculture in 1962, serving as a Foreign Animal Diseases Diagnostician and Field Veterinarian until he retired in 1984.

### Recent graduate establishes geography bursary

A bursary is a welcome gift to receive as it allows students to concentrate on their studies without the need for part-time employment.

This allows them to fully embrace student life by joining different clubs and societies, developing important life skills as well as making new lifelong friends.

Recent BSc graduate Ross Fleming realises the impact a bursary can have on a student's education: 'Financially, university is a challenge for everyone. I have been fortunate to work at the University during my undergraduate



and postgraduate studies. Without this, I would have struggled with living costs on loans and may have been unable to continue with my studies. Coming to the end of my undergraduate degree, I decided it was the right time to give something back by establishing a bursary. It will help a new student coming to the University each year from my former high school, Doon Academy in Ayrshire, to study geography for the first year of their studies. ## Gift wings its way from the Moffat Trust

A charitable trust, which was formed following the death of Jim Moffat, co-founder of the popular Scottish travel agency AT Mays, has made a major gift to the Small Animal Hospital Campaign.

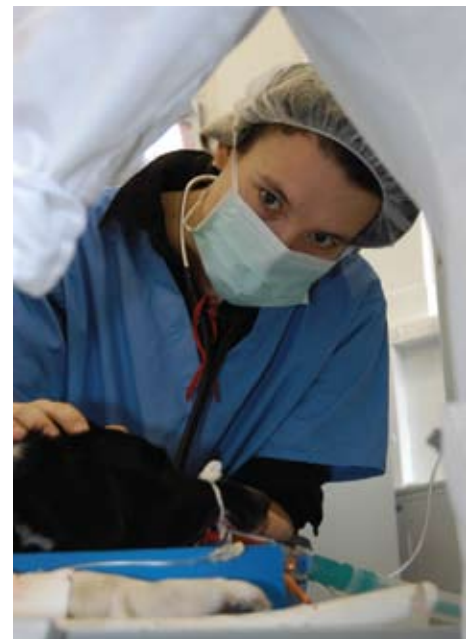
The Moffat Charitable Trust has pledged £60,000, which will go to support the chemotherapy and isolation unit in the new building.

'In the past, we had a long and happy association with AT Mays, when the Faculty of Veterinary Medicine booked all travel through the company,' said the Dean, Professor Stuart Reid. 'I am delighted that this link will be celebrated in perpetuity by naming this important function within the hospital.'

At its peak, AT Mays, which was based in Saltcoats in Ayrshire, was one of the four largest travel agents in the UK, employing 2,500 staff in 272 branches. In 1988, the firm was sold to the Royal Bank of Scotland and 11 years later, the Moffat Charitable Trust was established, predominantly to support medical and educational establishments and places where the company had prospered.

'When we are making donations, we tend to start in Saltcoats and radiate out,' explains chairman of the Trust, Jamie Moffat. 'Before we make a decision, we ask whether there was a local connection or whether there was an AT Mays in the area, because we feel that some of the money was generated in that local community and we are giving it back to them.'

'We are very aware that the Small Animal Hospital provides a valuable service to communities throughout Scotland and we are delighted to be able to support it in this way.'

## Celebrating a decade of giving

In 1999 the Chancellor's Fund Advisory Board was set up to disburse donated funds to where the need is greatest.

'This year we provided a grant to allow a team to enter an international engineering competition to design and build a single-seat high-performance race car. Another award has funded summer studentships allowing Physiology & Sports Science students to work with elite athletes.'
