PHEHTA to Start



PHEHTA (the Planetary Health Economics and Health Technology Assessment group) was officially started in December 2023 with an inaugural meeting attended by 5 members. Led by Dr. Nicola McMeekin, PHEHTA's remit will take two main approaches: to assess practical sustainability within the Clarice Pears Building, and to examine HEHTA's research interests through the lens of sustainability and the environment.

PHEHTA's first tasks include checking the university travel policy, identifying search engines with the least impact on the environment, confirming what happens to waste in the office, and liaising with PGT leads to examine sustainability in taught courses.

Evidence Synthesis Group Meets in Glasgow

HEHTA was delighted to host the first annual in-person meeting of the Evidence Synthesis Group (ESG) at the Complex Reviews Synthesis Unit (CRSU) on 5th and 6th February.

One of nine specialist research groups commissioned by NIHR's Evidence Synthesis Programme, the ESG at CRSU was last year awarded grant funding of £2.5 million over 5 years to conduct evidence syntheses spanning healthcare, public health, and social care. These projects may be requested directly by stakeholders, such as public health and social care providers (including NHS trusts) and patient communities, or



identified through NIHR processes.

HEHTA team members within the ESG were joined by project partners from the Universities of Leicester and York, Cochrane UK, as well as collaborators within the University of Glasgow. The group, led by Professor Olivia Wu, had a productive meeting discussing the progress of the currently allocated reviews, app development, patient and public involvement, and opportunities for future collaborations and expansion.


