Notes on contributors

Isabella Clough Marinaro received her PhD in 2006 from the University of Bath for her thesis entitled 'Public Discourses and the Marginalization of Roma/Gypsies in Rome'. Her research focuses on the evolving conditions of Roma communities in Italy and the policy processes which affect them. She recently co-founded the American University of Rome's Center for Research on Racism in Italy and is organising a cycle of conferences and publications on immigration and multiculturalism. Jason W. Davidson is Associate Professor of Political Science and International Affairs at the University of Mary Washington.
