### **Director's Report**

During the past year, the Centre for Business History in Scotland has continued to support and carry out a range of activities involving scholarly research and dissemination, postgraduate supervision, and archival usage and development. I would like, though, to highlight just a few particularly significant developments over the reporting period, some of which are the culmination of a number of years of hard work and achievement, with others indicating exciting possibilities for the coming year and beyond.

By far the most gratifying news this past year was the award in March of the prestigious 2013 Ralph Gomory Prize of the American-based Business History Conference for the best book in business history in 2012 to Mark Freeman, University of Glasgow, Robin Pearson, University of Hull, and James Taylor, University of Lancaster for their book, *Shareholder Democracies? Corporate Governance in Britain and Ireland before 1850* (Chicago: University of Chicago Press, 2012). I would like to congratulate all three authors on this major accomplishment, and in particular Mark Freeman as a member of the Centre for Business History in Scotland. It should be noted that the book manuscript was discussed by a small group of experts in a workshop sponsored by the CBHS in March 2008. The authors expressed their gratitude for this opportunity, which, as they acknowledged in the book, helped them improve their work substantially.

We are also delighted to welcome two new members of the Centre, the Economic and Social History subject area, and the University of Glasgow, one of whom has started already, and one of whom is beginning work on 1 July 2013. Professor Jeff Fear is the newly appointed Professor of International Business History and has joined us this spring. Professor Jim Tomlinson is the newly appointed Professor of Economic and Social History and will start in July. Both complement and extend existing strengths of the Centre.

In addition, a number of publications reflecting research and writing over a number of years are in press this spring and will appear in the course of the next few months. Many of them involved funding from the Lind Foundation, and all benefitted from the authors' close connections with the Centre. Tony Slaven's long-awaited book on British shipbuilding will appear in June, and a book of shipbuilding interviews compiled by him and Hugh Murphy will appear in the autumn. Both Tony Slaven, my predecessor as Director, and Hugh Murphy, a former employee of, and now Honorary Professor in the Centre, have long associations with us, but what is important to mention is that the interviews book resulted from a major project undertaken in conjunction with the CBHS and the Aggregate/Lind Foundation, supported also by outside funding.

But that is not all: Stephen Sambrook's study of the optical munitions industry's development through the early 1920s, which is a heavily revised version of his PhD thesis done under my supervision in which the Barr and Stroud firm features particularly prominently, will appear in June 2013 as well.

In the autumn, *The Business of Waste*, a history of the emergence of waste management in the UK and Germany since 1945 and co-authored by myself, Stephen, and Roman Köster, will appear in print. This book benefitted from seedcorn money provided by the Aggregate/Lind Foundation in 2006, which in turn translated into major funding from the Economic and Social Research Council (ESRC) between 2007 and 2010.

In addition to all of this, Jeff Fear, who has just joined the Centre as a member, has a co-edited volume on family multinational enterprise which is appearing in June.

This outpouring of research deserves to be celebrated, and there will be book launches organised to this end in the autumn. The first of these will be held in conjunction with a workshop on maritime history to be held in late October at the Riverside Museum and an event to mark the establishment of a new organisation, the Scottish Maritime History Council.

This will include a study of the trade in cinchona bark, from which quinine was extracted after 1825. This includes imports from Peru from 1700 and from the middle of the nineteenth century from India and Batavia where cinchona was naturalised. At its peak the UK was importing vast quantities of cinchona or Jesuit Bark and the re-exporting it to pharmaceutical companies in Germany, who dominated the trade in alkaloids. The resulting book will be published in 2014.
