Response - Key points

• Causes of anti-social behaviour outlined in the strategy are symptoms of deeper lying problems associated with low income, poor housing, lack of opportunity & poverty.

• The strategy will be imposed on top of a system which is currently both under resourced and subject to a pending (now present) review.



• Mechanisms to engage communities and foster understanding, such as mediation, were not been considered.

• The Children's Hearing System already has powers to use restorative and contractual methods to address anti-social behaviour BUT it currently the lacks resources & supporting services to effectively implement these.



- If ASBO's are to be extended to under 16's, they must be accompanied by strict guidelines concerning rights of appeal and a regular review period.
- Electronic tagging may result in more young children being sent to secure accommodation.
- More support is required for vulnerable families earlier.



- Parenting orders may be useful in some circumstances, as long as they are accompanied by clear support for the parent, the child and the family as a whole.
- ASBO's should <u>not</u> be linked to tenancy. It will result in increased pressure on already vulnerable families.



• Giving increased powers to police to disperse groups will not address the problems of antisocial behaviour. More investment is needed in youth work services.

• The strategy made no mention of young people with mental health problems or other disabilities. Clear guidance on this is needed.



- The strategy appears to run counter to the Scottish Executive's drive towards integration of services, particularly those aimed at vulnerable groups.
- Sure Start Scotland, Changing Children's Services Fund, Action Plan on Youth Crime, Youth Courts & Fast-Track Children's Hearings what about these?
