Academic Progression: You must have successfully completed the last course studied in the UK that your current visa was granted for to be demonstrating academic progression and to be eligible to apply for a Student visa inside the UK, unless you meet one of the academic progression exemptions. If you are demonstrating academic progression as you successfully completed the last course studied in the UK on your current visa, but your CAS does not bear a statement confirming you are demonstrating academic progression and how, you will need to provide documents to show you meet the academic progression requirements with your visa application.

1. **ST 14.3.** An applicant will show academic progress if they are applying for any of the following:
 1. (a) to progress from a bachelor's to master's level course which is part of an integrated master's course, where the applicant has been offered a place on a higher-level course by the [student sponsor](#) after an assessment of their academic ability; or
 2. (b) to progress from a master's to a PhD which is part of an integrated master's and PhD programme, where the applicant has been offered a place on a higher-level course by the [student sponsor](#) after an assessment of their academic ability; or
 3. (c) a course which is above the level of the previous [course of study](#) for which they were last granted [permission](#) unless:
 1. (i) the [student sponsor](#) is a [higher education provider](#) with a [track record of compliance](#); and
 2. (ii) the course is at [degree level](#) or above; and
 3. (iii) the new course is at the same level as the previous [course of study](#); and
 4. (iv) the [student sponsor](#) confirms that either:
 1. (a) the new [course of study](#) is related to the applicant's previous [course of study](#) (meaning that it is either connected to the previous course, part of the same subject group, or involves deeper specialisation); or
 2. (b) the combination of the previous [course of study](#) and the new [course of study](#) support the applicant's genuine career aspirations.

Academic Progression continued:

1. ST 14.4. An applicant does not need to show academic progress where they:
 1. (a) are applying to re-sit examinations or repeat modules under ST 14.5; or
 2. (b) have previously re-sat examinations or repeated modules under ST 14.5. and are applying to complete the course for which those examinations were re-sat or modules repeated; or
 3. (c) are applying to continue studying with their current [student sponsor](#) for the purpose of completing the PhD or other doctoral qualification for which study was undertaken during their last period of [permission](#) as a [Student](#); or
 4. (d) are making an application to move to a new [student sponsor](#) to complete a [course of study](#) begun at a [student sponsor](#) that has subsequently had its licence revoked; or
 5. (e) are applying to undertake a role as a [Student Union Sabbatical Officer](#); or
 6. (f) after undertaking a period as a [Student Union Sabbatical Officer](#) are applying to complete the qualification for which the [Confirmation of Acceptance for Studies](#) was assigned before that period; or
 7. (g) are applying for [permission to stay](#) under the [Doctorate Extension Scheme](#) or as a [postgraduate doctor or dentist](#) on a recognised Foundation Programme; or
 8. (h) are applying to undertake an intercalated bachelor's or master's degree course or PhD where they are studying medicine, veterinary medicine and science, or dentistry as their principal [course of study](#), or to complete their principal course, having completed a period of intercalation; or
 9. (i) are applying to undertake a study abroad programme or [work placement](#) which is both integral to and assessed as part of the course, or to complete their course, having completed a study abroad programme or [work placement](#).

If your CAS states you are exempt from demonstrating academic progression due to resitting or repeating exams or modules for your course for example, and where you changed your course of study on your current visa without completing the previous course, the Student Guidance says you must submit transcripts to show you have previously sat the exam or exams or taken the module or for your current course for your visa application.
