My teaching capacity as a GTA and marking assessments for Economic and Social History Levels 1A and 1B.

Details:

I have completed my first chapter as well as my second and have sent these to my supervisors. I have written the literature review, introduction and background, context and specifics of the international airline market. As such, I believe I am at a good progress with my dissertation. Currently, the pandemic has affected my access to resources as detailed below, which will have an impact.

I have also submitted a document addressing the way forward with my dissertation. We have discussed this recently and we have agreed upon what to do next. The dissertation will prioritise processes of privatisation in a chronological manner.

We have also discussed about applying to the MEXT and JASSO upcoming scholarships for funding my Kyoto years. These applications will take place over the summer. The provisional move to Kyoto would be around October-November.

I have received help with my first publication from my supervisors. My journal article has been written and presented to several seminars to good effect. This article has been sent to Business History Review and it is now under Revise and Resubmit with minor improvements with Business History. This has helped me learn more about the publication process. The article is on the causes behind British Airways' privatisation.

I have also learned more about how to present at seminars and tutorials/conferences. I have participated in several ones this academic year, including at the Economic

History Society, Business History Seminar, Glasgow, Oxford, Kyoto, etc. At these, I have presented my upcoming article as well as my PhD dissertation research.

I have also continued studying Japanese in preparation for my upcoming years at Kyoto University. I have also kept in touch with several academics there to establish links.

Challenges:

The current pandemic is impacting on my ability to access primary sources through archives.

National archives and company archives are also closed or have limited their operations.

There may have to be a reliability on online digital resources for future research.

Next steps:

The next steps would be to get in touch with relevant archives as possible to have access to electronic and digital resources. As travel is disrupted until I receive a vaccine against COVID-19, I will rely on digital resources and ask for digital copies where possible. As such, the upcoming academic year will mainly look at gathering sources and complete a new chapter.

As I have finished submitting my journal article, have presented widely, taught at undergraduate level, and have left the IMF project, my entire attention will now be focused on my dissertation. These experiences have been valuable and will prove useful for my future prospects.

On a separate note, the upcoming move to Kyoto University and the administrative and moving tasks which come with it will inadvertently take some time and will impact on progress.

I have been enjoying my time as a GTA, where I have taught to several tutorial groups in ESH 1A and 1B at Glasgow. I have also marked assessments and helped students face-to-face and by e-mail. It has been a valuable experience.

My supervisors, Ray Stokes and Takafumi Kurosawa, have been very helpful and supportive with my dissertation, publication, and teaching, this is especially true given this pandemic context. I am thankful for their help.

"The Global Scotch whisky industry 1918-2018 – a spirit of success?", commenced September 2019

Supervised by Dr Niall G MacKenzie, Adam Smith Business School, University of Glasgow and Dr Christopher W Miller, Economic & Social History, University of Glasgow.

I would like to start first by thanking the Board of Trustees, the beginning of the pandemic last year did not afford me the platform to formally give my appreciation for their support of this project. Thank you, I am grateful for this opportunity and passionate about the research. This report covers a year of work that began six months from the beginning of my PhD research period. The past year has presented unexpected challenges to the research plan, but I have consulted with my supervisors on the changing situation and have aimed to work conscious as circumstances developed and changed. In recognising the limitations of access to both library materials and archive materials the focus has been on developing my research questions and writing my first section of my thesis. In this way the primary work over the course of the year has been to develop my introduction, literature review, source analysis and methodology. As access continued to be an issue the tentative plan for case studies changed, we looked for alternatives as the crisis unfolded, for example, using digital resources such as newspapers with advertisements and digital material culture such as whisky collectibles to connect to the proliferation of the industry globally and culturally. During the first term of the current academic teaching cycle, I was able to focus on professional development as a graduate teaching assistant in economic and social history. Ultimately, this year has focused on my development as a researcher and academic writer stretching my abilities to meet the challenges of the scope of this project and academic work in the current climate.

In concert with my supervisors as I have been writing and revising the first section of my thesis, I have been developing skills in content editing. The history of the whisky industry situated within the history of Scotland, the United Kingdom, and especially Business History has a wealth of research focus. In content editing I am learning to focus on the bigger research questions around globalisation and how I can shape my thesis to answer them. Developing a methodology section has helped to illustrate areas where there have not been robust scholarly treatments in the literature, for when I access primary sources, I can easily illustrate what I can do with them. I have been advised that emphasis is needed on being selective so that when archives open, the materials I consult serve in answering my research question. The scholarly literature that exists helps to establish the formation of the whisky industry, my job is to continue the story and pull together the strands that explain the paths taken by the industry actors bringing it forward to a more recent point, then analysing critically how the industry looks different from 1918. The story and the hook of the thesis is situated around globalisation and will discuss the way in which the whisky industry has transformed reflecting its concurrent roles as national beverage, cultural heritage, and multi-national manufactured luxury good.
