

Director's Report

The pandemic has continued to affect archival access and in-person events for all members of the business history profession, and thus has affected much of the usual activity of the Centre for Business History in Scotland and its members. Nevertheless, as can be seen in the entries below, the members of the Centre have been publishing vigorously over the past year in high-quality journals and other outlets, and dissemination of research in conferences, public lectures, and other events has also been strong, albeit mostly online. Moreover, in spite of restrictions on travel and archival access, PhD students associated with the Centre have been making excellent progress on their research. Three students associated with the Centre have been making excellent progress on their PhD theses in the past year, and we are also pleased to welcome new students to the Centre, including one who has started the dual PhD programme with Nankai University and one who is commencing the dual PhD programme with Kyoto University.

The past year has also seen the appointment of several new colleagues in the Economic and Social History and Politics/International Relations subject areas who have teaching and research interests in business history. As they arrive, they are being invited to become members of the Centre. This is a very welcome development, which will allow the subject areas to meet their teaching obligations more effectively. It will also broaden and deepen the range of research conducted in conjunction with the Centre for Business History in Scotland.

We are now fully engaged in planning the resumption of many of the Centre's "normal" activities in the coming year, including participation by members in a range of conferences and archival research visits. The Centre will also facilitate this revitalisation of the profession through: co-sponsoring the Scottish Maritime History Lecture and Conference, which was suspended for the past two years; funding in support of the 18th annual conference of the History of European Integration Research Society (HEIRS); joint sponsorship of a conference in Geneva on business in the Cold War; sponsorship of a social event at the first in-person conference of the Association of Business Historians, which is being organised by Strathclyde University and will be held in Glasgow in July 2022; funding of four researchers who will visit the University to make use of the business history collections in Glasgow University Archives; and, co-sponsorship with the University of Tübingen of an international summer school for PhD students. Centre members are also continuing work with the Archives Service to integrate business archives fully into teaching at both undergraduate and postgraduate levels.

We are looking forward to a strong revival of the interactions that are so vital to the profession during the coming year.

During the past year Professor Dupree's co-edited (with Anne Marie Rafferty and Fay Bound Alberti) book, Germs and Governance: The Past, Present and Future of Hospital Infection, Prevention and Control was published by Manchester University Press in April. The book was launched in August at the Royal College of Nursing in London at a 'hybrid' launch, with the editors and a commentator forming an 'in-person' panel, together with two contributors, one in Switzerland and one in Newcastle, speaking about the book to an online audience of c. 400 and a small 'in-person' audience of c. 30 at the RCN (who enjoyed their first 'post-lockdown' wine and canapes!).

The volume has been very well reviewed by Scott Podolsky of Harvard University in Social History of Medicine. He writes, 'Germs and Governance brings together a diverse array of scholars to give the topic its due attention, presented here as a series of eleven articles, framed by an introduction and incisive conclusion... Ultimately, it is this call for - and demonstration of - such cross-disciplinary approaches to an enduring hospital and societal concern that makes this a particularly useful volume for historians, clinicians, and policymakers alike.' https://doi.org/10.1093/shm/hkab080

Germs and Governance is an interdisciplinary volume brings together work from leading historians, researchers, healthcare professionals and policy makers to

consider the history, practice and future of infection control in the UK hospitals, drawing on comparisons with the United States, Europe and Australia. Through personal reflections, historical case studies, policy debates and accounts of specific hospitals this volume explores the roles of technology, healthcare professions, emotional attitudes, and human factors and ergonomics in the translation of scientific knowledge into clinical practice. These insights into the theory and practice of infection control in the operating room, bedside, laboratory and boardroom suggest that while it is important to invest in the development of new classes of anti-microbial drugs, it is equally important to devote substantial resources to methods of hospital hygiene and infection control, not least nursing, management and hand washing.

Germs and Governance is one of the outcomes of Professor Dupree's major research grant, 'From Microbes to Matrons: the history of infection control in British hospitals, c. 1870 to 1970', from the Leverhulme Trust, held jointly with Professor Anne Marie Rafferty of King's College London and jointly between the University of Glasgow and King's College London.

PhD Title: "Airline privatisation in Europe and its impact upon labour, performance, and customers", commenced September 2019

I would like to summarise my progress for the academic year 2021-2022. This includes developments regarding my dissertation research on airline privatisation in Europe, other academic involvements, and my progress regarding my visa status to travel and research at Kyoto University as part of my joint degree.

As part of the coronavirus restrictions, many of the relevant archives have been closed in 2020 and 2021. Nonetheless, before the Omicron restrictions of December 2021, I managed to travel to archives in France and Germany over the months of October and November 2021 to collect material for my research. These trips have been successful because I have been translating and taking notes from this material since December. I believe I will finish the analysis at the end of April. At the same time, I have been working together with my supervisors, professors Ray Stokes (Glasgow) and Takafumi Kurosawa (Kyoto), at focusing the research and pinpointing the main question of the dissertation for the upcoming chapters in light of this new material. I have sent my supervisors documents and we have had discussions about how to proceed. Two chapters have been completed and they relate to the introduction as well as background and context of the airline industry. The plan for the rest of 2022 is to finish the archival material analysis and write the next two chapter drafts.

I have also been involved in other academic opportunities. After my article on British Airways was published in *Business History* in June 2021, I am now publishing a book review in the same journal on Takeshi Sakade's book on the British aircraft industry. I have presented my journal article at the Economic History Society 2021 conference. Kyoto University, and at the 2022 Business History Conference. My submission has also been accepted for presentation at the 2022 European Business History Association conference. 1 have also been awarded the 2022 MEXT (Monbukagakusho) scholarship from the Japanese government, after successfully applying and receiving the 2021 MEXT scholarship. Due to my priorities with my own dissertation research, I had to politely decline an offer to contribute with a chapter on an edited Routledge volume, although an opportunity for future collaboration has been established.

I am currently involved in re-applying for a visa to enter Japan as part of my degree between Glasgow and Kyoto. I was originally granted a visa in December, then Japan enforced new restrictions because of Omicron. As Japan is now relaxing its restrictions, I am scheduled in April to apply for a new visa, then make the necessary preparations to travel to Kyoto. All of these opportunities would not have been made possible without the generous support of the Centre and its people. Ray Stokes and Takafumi Kurosawa have been outstanding supervisors and supportive with the challenges I've encountered. I am very grateful to them and their kindness and experience. Christine Leslie has very kindly and efficiently helped and supported me with travel arrangements and administrative aspects. The Centre has generously funded my research and travel arrangements. I sincerely thank you for your help and support!

The Globalisation of Scotch whisky, 1890-1990: A Spirit of Success?, commenced September 2019

The past year has seen some changes to my research and writing plans as I have continued to feel the effects of archive closures and the uncertainty of travel. Early plans in my PhD to include research on the influence of exporting Scotch whisky to Japan and the relationship with Foreign Direct Investment and Multinational enterprises in Scotland have been abandoned as hope to travel to Japan has evaporated. For a time, the possibility of travelling to the US and making use of the archives of Seagram's held at the Hagley Library and Archives was also considered. In the end, the wealth of material in the Central Belt combined with the extensive digital archive I began accumulating during the lockdown offers a novel contribution to Business History telling the story of globalisation of Scotch whisky through the wealth of advertising images and material culture such as printed materials for pubs or promotional items for the collector. Additionally, digitised newspapers and the records from Hansard, give a glimpse into the different voices in the industry over the last 150 years and illustrate the role government has had in the activity of the whisky trade. The beginning periodisation of my thesis has shifted from 1918 to 1890 so that I can better capture the foundations of brand identity in the Scotch whisky industry as well as the increase in exports prior to WWI. This culminates in a chapter covering 1890-1918 and will be a striking contrast to changing activity in the industry over successive chapters. The current plan is for a following chapter on 1918-1945 and one 1945-1990.

In positive news on the archive front, in March 2022 permission was granted and I was able to begin research of the Whyte & Mackay material that has been deposited at the University of Glasgow Business Archive. The Ballast Trust has been processing this material for several years and have very generously allowed me to visit the material in their possession. I have also spoken to the archivist for Dewar's, owned by Bacardi and located in Glasgow, and there is a little hope that I will get a chance to see some of their material. At this time, it is planned that I will have conducted all my archive visits before the end of this summer 2022. I also plan to have drafts of my three chapters so that I can begin my final writing year identifying any remaining areas needing research and begin writing my conclusion.

When I have not been able to visit the archives of the last year, I have spent time expanding my digital archive collection. This includes collecting images of advertisements, focusing on the narrative that can be told about how the industry portrayed itself globally and for different markets, and how brands have mined their pasts and Scottish history for marketing. I also compiled a collection of the trademark files from the UK IPO as this helps to show trends and changes over time in brand identity as well as what competitors were doing. Additionally, when access has been limited, I return once again to my literature review. With my periodisation shifting earlier I needed to gain a better understanding of the threat of nationalisation of the liquor trade in the UK during WWI as well as the activity of Scotch whisky exports in the US following the national prohibition in 1920. I have also looked to the export experience of multinational enterprises such as Lever, Coats, and Coca-Cola and this has given me greater insight in understanding the unique features of the Scotch whisky trade globalising.

Thank you for your interest and support of my research. Despite the challenges I look forward to the direction the project has taken and hope to be sharing it next year.
