

Notes on contributors

Daniele Albertazzi is Senior Lecturer in European Media at the University of Birmingham. His research interests concern the communication strategies, styles of propaganda and mass media use of political parties in contemporary Europe, as well as Italian politics, Swiss politics and populism in Western Europe. He has published in journals such as *Modern Italy*, *National Identities*, *Politics*, *West European Politics*, as well as numerous book chapters. His latest books are: *Twenty-First Century Populism: The Spectre of Western European Democracy*, co-edited with Duncan McDonnell (Palgrave, 2008); *Resisting the Tide: Cultures of Opposition Under Berlusconi (2001-2006)* (Continuum, 2009), co-edited with C. Brook, C. Ross, and N. Rothenberg; and *The Media, An Introduction- Third edition* (Pearson, 2009), co-edited with Paul Cobley. At the moment, he is working on a project that will result in the publication of a monograph on *Regionalist vs. Nationalist Populists in Power: Actions and Reactions* (with Duncan McDonnell).

Gianfranco Baldini is Associate Professor of Political Science at the University of Bologna and Research Director at the Istituto Cattaneo of Bologna. His main research interests are in the area of party and electoral systems, regional and local policy, and more generally the Italian, French, British and European Union political systems. His latest publications include: *Politica in Italia 2009* (Il Mulino, 2009), edited with A. Cento Bull and also published in English as *Italian Politics 2008* (Berghahn Books, 2009); *Elections, electoral systems and volatile voters* (Palgrave, 2008), with A. Pappalardo; *La Francia di Sarkozy* (Il Mulino, 2007), edited with M. Lazar. At the moment he is working on two books, one on devolution in the United Kingdom and the other on the next British general election (edited with Jonathan Hopkin, Il Mulino/Manchester University Press).

Clodagh Brook is Senior Lecturer and Head of the Department of Italian Studies at the University of Birmingham. Her current research centres on Italian cinema, although she also works on poetry. She has published in *The Italianist*, *Italica*, *Forum Italicum* and *Italian Quarterly*. Her latest books are: *Resisting the Tide: Cultures of Opposition Under Berlusconi (2001-2006)* (Continuum, 2009), co-edited with D. Albertazzi, C. Ross and N. Rothenberg, and *The Expression of the Inexpressible in Eugenio Montale's Poetry: Metaphor, Negation, and Silence* (Oxford University Press, 2002). At

present, she is finalising a monograph on Marco Bellocchio's cinema (*Marco Bellocchio: The Cinematic I in the Political Sphere*, University of Toronto Press, 2009).

Mauro Calise is Professor of Political Science at the University of Napoli "Federico II". He is the current President of the Italian Political Science Association (2007-2010) and the former vice-President of the International Political Science Association (2000-2003). He has published extensively on several areas, including state theory, political parties, executive elites, political communication and concept analysis. His recent interests focus on Internet epistemology and culture. Among his books are: *La terza repubblica. Partiti contro presidenti* (Laterza, 2006), *Il partito personale* (Laterza, 2000), *La costituzione silenziosa: geografia dei nuovi poteri* (Laterza, 1998). He is currently working with Theodore J. Lowi on *Hyperpolitics: An Interactive Dictionary of Political Science* (University of Chicago Press, forthcoming).

Maurizio Carbone is a Senior Lecturer in the Department of Politics at the University of Glasgow, where he also directs the Scottish Jean Monnet Centre of European Excellence. His main research interests focus on the external relations of the EU, development policy, foreign aid and the politics of international development, as well as on European and Italian Politics, particularly foreign policy. He has published, *inter alia*, in *West European Politics*, *Politics*, *Global Governance*, *Journal of European Integration*, *Journal of Modern Italian Studies*, and *Modern Italy*. His latest books include: *The European Union and International Development: The Politics of Foreign Aid* (Routledge, 2007), and two edited books, *Policy Coherence and EU Development Policy* (Routledge, 2009) and *National Politics and European Integration: From the Constitution to the Lisbon Treaty* (E. Elgar, forthcoming). At the moment he is working on a book on Italian foreign policy and another book on the EU's relations with Africa.

Elisabetta De Giorgi has a PhD in Comparative and European Politics from the University of Siena, where she wrote a thesis on parliamentary opposition in Western European democracies. She is currently a post-doctoral fellow at Centre for the Study of Political Change (CIRCaP) in Siena and she contributes to the research activities of the Centre, in particular to its work on Italian parties and parliament from a comparative perspective.

Sergio Fabbrini is Professor of Political Science at the University of Trento. He has authored seven academic books, co-authored one book, edited and co-edited five other books, and published eighty articles in scientific journals or chapters in edited books in the fields of Comparative, American, EU, and Italian politics, and in the fields of political theory, political economy and public policy. His current research project concerns the comparison of the EU and US political systems and the future of transatlantic relations; the constitutionalisation of a post-national democracy in Europe; the Europeanisation of Italian politics and institutions.

Paul Furlong is Professor of European Studies and Head of School in the School of European Studies, Cardiff University. He has published widely on Italian and European Politics in numerous journals, including *West European Politics*, *Parliamentary Affairs*, *Government and Opposition*, *Journal of Legislative Studies*, and *Politics*. His main research interests are in political parties, constitutional developments and regional reform, as well as in political economy and religion, and the politics in Italy. His books include: *Modern Italy: Representation and Reform*, London (Routledge, 1994), and *The European Union at the crossroads*, ed. (Earlsgate Press, 1995).

Carlo Fusaro is Professor of Public Comparative Law in the Department of Public Law of the University of Florence. His main interests are the form of government, institutional reforms in Italy, majoritarianism and electoral laws, the role of the President of the Republic in Italy and other heads of state in Western democracies (especially France). His latest publications include: *Il governo delle democrazie* (Mulino, 2009, 3rd revised edition); *Corso di diritto pubblico* (Mulino, 2008, 5th edition) with A. Barbera; *La legislazione elettorale italiana* (Mulino, 2008), co-edited with Roberto D'Alimonte. At the moment he is working with Dawn Oliver on a book on *How Constitutions Change*, which should be finalised by the end of 2010.

Francesco Marangoni obtained a Ph.D in Political Science, Comparative and European Politics from the University of Siena, in 2007. He is currently a post-doctoral fellow in the faculty of Political Science of the University of Bologna at Forlì. He is affiliated with the Centre for the Analysis of Public Policy (CAPP), a research unit of the Department of Political Science at the University of Bologna. His most recent books include: *Assessing the Quality of Democracy* (John Hopkins, 2005, with Larry Diamond); *International Actors, Democratization and the Rule of Law: Anchoring Democracy?* (Routledge, 2008, edited with A. Magen, 2008); and *Democratization and the European Union: Comparing Central and Eastern European Post-Communist Countries* (edited with W. Sadurski, Routledge, forthcoming).

James L. Newell is Professor of Politics at the University of Salford. He is co-editor of *European Political Science* and a member of the Executive Committee of the UK Political Studies Association. He has published numerous articles and book chapters on various aspects of Italian politics. Recent books include: *Parties and Democracy in Italy* (Ashgate, 2000); *The Italian General Election of 2001* (ed., Manchester University Press, 2002); *Italian Politics: Quo Vadis?* (ed. with Carlo Guarnieri, Berghahn, 2005); *Italian Politics: Adjustment Under Duress* (with M. His new book, *The Politics of Italy: Governance in a Normal Country* is due to be published by Cambridge University Press in late 2009.
