### "Public Participation in Water Governance in China, North Africa and the EU"

### 15 January 2015, University of Glasgow 25 Bute Gardens, G12 8RS Glasgow

For nearly three decades, "Public Participation" has been promoted as a paradigm for water management. Since the end 1980s, The World Bank has made the formation of Water User Associations in agricultural water management a pre-condition to their loans, - with mixed results. In the 1990s, nitrate groundwater pollution in some European contexts led to the participation of farmers in the governance of water pollution prevention. The EU Water Framework Directive, which entered into force in 2000, seeks to encourage the active participation of all interested parties in the implementation of the Directive. In recent years, also in countries with political traditions different from Europe, like China, experiments with public participation in environmental governance have been made.

This half-day conference brings together academics and practitioners who will present on different experiences with public participation in water governance. It will stimulate discussions about what public participation actually is in the respective context, which kinds of changes in water governance public participation has brought about, and how these changes can be further built upon to support effective water governance.
