

Information is vital to the University's mission. We are committed to protecting its confidentiality, integrity and availability, and the privacy of students, staff and alumni and all individuals we work with.

The University of Glasgow classifies its information assets into risk-based categories for the purpose of determining who is allowed to access the information and what security precautions must be taken to protect it against unauthorised access.

## **Risk Classifications**

## **Application Risk Classification Examples**

An application is defined as software running on a server that is network accessible

Server Risk Classification Examples A server is defined as a host that provides a network accessible service.

<ul> <li>Servers used for research computing purposes without involving Moderate or High Risk data.</li> <li>Servers used to store published public data.</li> </ul>	<ul> <li>Servers handling Medium Risk data</li> </ul>	<ul> <li>Servers handling High Risk data</li> <li>Servers controlling access to other systems</li> <li>Email servers</li> <li>DNS and DHCP servers</li> <li>Active Directory servers</li> </ul>
