5. Entrance Requirements:

Practice requirements: Direct experience of youth or community work (usually 12 months or equivalent). Additionally, applicants should be highly motivated, efficient in time management and committed to participative learning.

Academic requirements: Applicants must demonstrate their ability to engage in study at higher education either by having Highers (4 Bs) or A levels (2 Bs and 1 C) or by illustrating their ability through previous work or voluntary experience. Applicants with HNC qualifications are eligible to apply for admission into year 2 of the programme. APL may be applied to admissions.

Current Practice: 40% of assessed student work is practice-based, therefore applicants must undertake 200 hours of community development practice (paid or voluntary) during each academic year.

8. Programme Aims:

This programme has been developed to enable students with experience of working in a community development or social action contexts, to reflect on and develop their practice and profession in the light of a wide range of theoretical perspectives, and gain professional qualification to practice community development in the UK. The Honours year provides opportunities for deeper engagement with specific aspects of the field; and a pathway for students to progress to postgraduate studies in our subject area or beyond.

The Aims of this programme are:

To equip students with the necessary practical skills, analytical tools and conceptual frameworks to be effective and innovative Community Development practitioners nationally and internationally across the various contexts and changing environments where social action takes place.

To teach the skills required for ongoing critical reflection and enquiry in Community Development practice from a range of theoretical perspectives and paradigms.

To provide students a context within which they can demonstrate their competence as practitioners to the National Occupational Standards for Community Development Work

9. Intended Learning Outcomes of Programme:

The programme provides opportunities for students to develop and to demonstrate knowledge and understanding, skills and other attributes as described below.

Knowledge and Understanding

By the end of this programme, students will be able to:

- Explain the principles, values, and complexities of Community Development
- Assess and analyse the strengths, weaknesses and applicability of a range of Community Development models and theories
- Explain a range of social theories in relation to community development work
- Discuss the principles of popular and public pedagogies

Skills and Other Attributes

By the end of this programme, students will be able to:

Subject-specific/practical skills

- Demonstrate practical competence in line with the NOS Community Development Work Standards
- Apply the principles and values of Community Development in a wide range of practical situations
- Evaluate models of Community Development and assess their applicability in a range of contexts
- Explain how a range of theoretical perspectives inform their practice

Intellectual skills

- Critically analyse social policy
- Analyse the contexts of community based practice
- Apply principles of popular and public pedagogies in a practice context

Transferable/key skills

- Employ effective communication, collaboration, and groupwork skills reflective of the context
- Identify and deploy appropriate research methods in a practice setting
- Develop strategies for effective self-evaluation and reflection

10. Typical Learning and Teaching Approaches:

Knowledge and understanding skills are taught through lectures, tutorials, seminars, and workshops

Evaluative thinking and the ability to synthesise material is developed through seminars, group work exercises, practical classes and workshops

Individual problem solving is learned through the facilitation and mentorship of group projects, the individual research project, and through critical analysis and development of practice

Development of self-reflection and evaluation is achieved through critical interrogation of practice by individual students, peers, and staff team

The approach to learning and teaching on the programme assumes that learners come with a wealth of experience, knowledge, and understanding that is drawn from substantial practical experience. It is therefore appropriate that there is an emphasis on co-investigation and problem posing as a teaching and learning strategy

11. Typical Assessment Methods:

Demonstration of competency as a community development practitioner will be assessed through:

Observation of practice

Written assignments

Oral presentations

Knowledge, understanding and skills will be assessed through:

Written assignments

Group presentations

Individual presentations and seminars

Individual research project

12. Programme Structure and Features:

The programme is designed to have multiple exit points to reflect the need for flexibility expressed by the student group. Consequently it is possible for a student to leave at the end of year 1 with a Higher Certificate in Community Development, at the end of year 2 with a Higher Diploma in Community Development, at the end of Year 3 with the BA in Community Development, or at the end of Year 4 with a BA (Hons) in Community Development.
